The sponsor is required to comply with the specific rules of the Trade Fair, as well as IFEMA's general rules of participation.

Payment for sponsorship must be made before the opening date of MOTORTEC AUTOMECHANIKA 2019. Invoices will be sent with bank details for making transfers.

LEGAL TERMS

Once the final details of the application have been agreed, you will receive the corresponding exhibition contract. We would remind you that you must make the payments indicated in this document within the specified time limits.

The applicant company states that they understand and accept IFEMA's Rules of Participation for Exhibitors: the General Rules of Participation at IFEMA, the Specific Rules for the Trade Fair, which are attached to this document, and the technical annexes to the General Rules that are available at all times on the IFEMA website, ifema.es, in the Exhibitor Area and on each trade fair's website.

The applicant consents to IFEMA (registered office at Feria de Madrid, Avenida del Partenón, 5 - 28042 Madrid) processing the data provided in this application form for the purpose of managing your contractual relationship with IFEMA and your participation in the corresponding trade fair, and for the purpose of keeping you informed of our activities, content and services, through regular trade communications, including by electronic means. The information you have provided will be safeguarded at IFEMA for the implementation of the contractual relationship and, unless consent is withdrawn, during the corresponding prescribed periods. The legal basis for processing your data is the consent to and management of a pre-contractual relationship (Articles 6.1(a) and (b) of the GDPR).

Once you have signed up as an exhibitor, your business details (e.g. company name or trade name, postal and/or email address, telephone and fax number and contact person) may be provided, with an obligation to maintain confidentiality, to IFEMA's partner companies, either for the organisation of the trade fair or for providing ancillary or added value services, with the aim of ensuring that information is disseminated about your activities and services and that your needs are met. With the exception of the cases described above, personal data will not be communicated to third parties unless required by public administrations and/or judicial authorities pursuant to a legal obligation.
