





## 25<sup>th</sup> TOURISM COMPETITION FITUR ACTIVE

**RULES 2020** 

IN COLLABORATION WITH

AireLibre





**#01** FITUR Activo and AireLibre magazine are organising the 25<sup>th</sup> Fitur Active Tourism Competition in the national and international sections.

#02 The 25<sup>th</sup> Fitur Active Tourism Competition aims at furthering the development and commercialisation of the tourism industry and promoting higher-quality tourism products within the framework of active tourism.

**#03** It shall be open to any product based on tourism involving adventure, culture, nature, wine & gastronomy, sport and environment, that is present as exhibitor or coexhibitor at FITUR 2020, whether national or international.

**#04** Each company may compete with any products it wishes up to a maximum of three. No products recognised in previous editions may be entered. The following should be submitted, by 30 November 2019, in Spanish or English:

- Information on the company entering and/or commercialising the product: full name and address, year of incorporation, number of workers and the company's corporate purpose.
- Information on the product: name of the product, description, year of creation, implementation period, permanent and temporary human resources used, involvement, if appropriate, of other resources and their promotion, marketing channels, agreements with other agents, target public, future development of the product, etc.
- Printed and audiovisual material that defines and describes the product.
- The fully completed registration form attached to the following address:

**#05** The Admissions Committe reserves the right of admission of the products entered in the Fitur Active Tourism Competition. Should a product not be accepted, the organisation shall inform the company that is entering said product.

#06 The following aspects shall be rated:

- Original idea.
- Product presentation and image.
- Contribution to the recovery of the environment and to sustainable development.
- Quality of infrastructures.
- Commercialisation and distribution channels.

**#07** The technical jury shall establish the prizes awarded in each edition of the Fitur Active Tourism competition based on the participating products and their quality, rating concepts relating to nature, adventure, culture, wine & gastronomy, environment, technological development, accessibility, etc.

#08 The jury's composition shall be the following:

- 30% end consumer: AireLibre readers shall cast their online vote on the FITUR website or the AireLibre website from 20 December onwards until 4 days before the competition verdict on COB of 12 January 2020.
- 30% tourism professionals: FITUR 2020 exhibitors, excepting the competitors, shall cast their vote from 20 December onwards until 4 days before the competition verdict on COB of 12 January 2020.
- > 10% media: they shall cast their vote from 20 December onwards until 4 days before the competition verdict on COB of 12 January 2020.
- 30% technical jury comprising representatives of the tourism industry.

#09 The verdict of the Fitur Active Tourism Competition shall be announced on the Thursday prior to the opening of the trade fair on 16 January 2020 and communicated to the winners on the following day, 17 January 2020.

**#10** The verdict of the Fitur Active Tourism Competition shall be irrevocable.

#11 The winners of the Fitur Active Tourism Competition shall receive an accrediting diploma during FITUR, in addition to the seal that identifies them as winners of the Fitur Active Tourism Competition 2020, which they shall be able to include in any physical and digital mediums they deem appropriate. At a later date, in the month of May, they shall be called to the official event staged by

FITUR, which shall be attended by the Secretary of State for Tourism, for the prize-giving ceremony of all the awards conferred during FITUR.

**#12** Winners of the Fitur Active Tourism Competition shall benefit from the following actions:

AireLibre shall disseminate the competition by publishing the participants and winners on their internet page (www. airelibre.com) and through the following actions of the magazine:

- October: competition notice in the magazine through the presentation of the distinctive seal.
- November and December: competition reminder page.
- From 15 December to 12 January: a list of the competing products shall be sent to 236,000 users of AireLibre via email, with a request for the vote of AireLibre readers, tourism professionals and specialised press.
- During FITUR: inclusion of the list of competing products in the FITUR AireLibre Guide (published by AireLibre on the occasion of FITUR) which is handed out free of charge to FITUR visitors (50,000 copies) and sent to the more than 236,000 users of AireLibre in digital format.
- February: dissemination of the distinctive seal and list of the competition winners.
- From March: month-by-month publication of each one of the prize-winning products (covering two pages).
- Mailing of a newsletter in which each prize-winning product may include any information it wishes as well as links to websites, videos, etc. This newsletter shall be sent to more than 236,000 related addresses owned by AireLibre.

FITUR shall support the dissemination of the Fitur Active Tourism Competition through:

- The distribution of the promotional brochure among all professionals participating in FITUR.
- The promotion of this information in the media through its press office.

**#13** AireLibre and FITUR reserve the rights over the 25<sup>th</sup> Fitur Active Tourism Competition.

#14 All participants accept this regulation. The organisation's criterion shall always prevail in case of doubt.
