## RESPONSIBLE TOURISM AWARD - LEGAL TERMS AND CONDITIONS

### Organisers

FUNDACIÓN INTERMUNDIAL, with registered office at C/ Irún 7 28008 Madrid (Spain) and Company Tax ID G-86143641; together with FITUR, with registered office at Avenida del Partenón 5 28042 Madrid (Spain) and Company Tax ID Q-2873018B, Instituto Tecnológico Hotelero (ITH), with registered office at Calle Orense 32 28020 Madrid (Spain) and Company Tax ID G-84106202, and the Organización Mundial del Turismo (OMT) convene between them this Responsible Tourism Award. Entries are invited from all companies exhibiting at FITUR 2020.

### Entry requirements

Companies wishing to be considered for the Responsible Tourism Award must be exhibitors at FITUR 2020.

No organizer company or any company directly related to an organiser may apply for the award.

### How to enter

Applicant companies may submit their award applications between **28 October and 3 January at 24:00 hours (GMT+1)**, both dates inclusive. Interested companies may submit entries in any one of the **4 available categories** according to the business sector they operate in:

- **Hotel and catering** (accommodation, food & beverage and related services)
- **Transport, Tourism products and services** (means of transport, airports, incentives and conferences, tour operators, travel agents, leisure, health...)
- **Destination** (FITUR exhibited countries)
- **Blogsphere** (blogs which have promoted or publicised Responsible Tourism actions).
- **Media** Journalists and media which have promoted, from their lines, the Responsible Tourism research.

Candidates can apply by completing the form on the FITUR website and on the Fundación InterMundial web describing the various policies or actions taken to promote/achieve responsible tourism in the last 2 years. The following details should be included:

- Award Category applied for
- Company name
- Company address
- Contact person (name and contact details)
- Name or title of the action or policy benefitting responsible tourism (up to a maximum of 3)
- Describe the action/s\*
- Additional information: if necessary, include additional information to help understand the action (attach only one document)

\*The jury may request original documents from the applicant as evidence of the actions submitted for consideration.

### Selecting the winner

The Jury, comprising renowned professionals from the tourism industry, will meet in the weeks following the applications closing date. One winner will be chosen in each category from among the applications received (and a destination chosen for special mention).

However, if the chosen winner fails to meet any participation requirement stated in these terms and conditions, a replacement winner will be chosen. If no applicant in a given category meets the entry requirements, the category will be declared abandoned.

### Award ceremony

The prize is a recognition award, with no financial consideration attached. The award results will be broadcast over the main national tourism industry media and also across social media and other proprietary organiser communication channels.

The winners will be notified by email and provided with details for collecting the award, during the FITUR exhibition days.

### Personal Data Protection

The company participating in the nominations for the Responsible Tourism Prize is responsible for processing the personal data of the contact person and providing them to FUNDACIÓN INTERMUNDIAL. FUNDACIÓN INTERMUNDIAL shall process those data exclusively for the purpose of administering the participation of companies nominated for this year's Responsible Tourism Prize, in order to contact the winners and present them with the prize.

With regard to that processing, FUNDACIÓN INTERMUNDIAL acts as the Processor of the data for which the participating company is the Controller, in accordance with the provisions of Article 28 of Regulation (EU) 2016/679 of 27 April 2016 ('GDPR'). FUNDACIÓN INTERMUNDIAL therefore undertakes to carry out that processing in accordance with the instructions of the Controller, in compliance with the provisions of the GDPR and any other applicable legislation. To that end, the company declares and warrants that it complies with the obligations relating to information, transparency and legitimate use of the data laid down in the GDPR and, in particular, that it has informed the relevant data subjects that FUNDACIÓN INTERMUNDIAL is going to process their data for the purposes of administering this year's Responsible Tourism Prize.

The participating company shall thus bear sole liability, in relation to FUNDACIÓN INTERMUNDIAL and to third parties, for any claims or actions, whether through the courts or out of court, based on non-compliance with the obligations laid down in the legislation applicable to the protection of personal data. It shall also compensate FUNDACIÓN INTERMUNDIAL for any damage arising from such non-compliance and shall reimburse it for any amount which FUNDACIÓN INTERMUNDIAL has had to pay out as a result of that damage, including possible fines from the competent authorities and/or damages claims.

Where the personal data provided by the participating company are altered or changed in any way, FUNDACIÓN INTERMUNDIAL must be made aware of that fact as soon as possible.

FUNDACIÓN INTERMUNDIAL, as the Processor, shall only use the personal data to which it has access for purposes directly related to the administration of the Responsible Tourism Prize and, once this year's proceedings have concluded, it shall delete those personal data, along with any medium or document containing any personal data which have been processed, or it shall return them to the participating company, at the company's discretion. The above notwithstanding, FUNDACIÓN INTERMUNDIAL may retain those data which it is legally obliged to retain, but only for the period of time and for the purposes prescribed by law.

Participating companies guarantee and are answerable for the truthfulness, accuracy, validity and authenticity of their personal information. Data subjects may exercise their rights of access, rectification and erasure, and also, in certain circumstances and for reasons related to their particular situation, rights to data portability and the restriction of processing, by sending a written request, with a copy of their DNI (Spanish identity document) or identity document, to the following address: C/ Irún 7, 28008 Madrid (Spain), marking the envelope 'Re: Data Protection', or by email to the following email address: [lopd@fundacionintermundial.es](mailto:lopd@fundacionintermundial.es). FUNDACIÓN INTERMUNDIAL guarantees full compliance with Organic Law 15/1999, of 13 December, on the Protection of Personal Data, with regard to the processing of the personal data collected for this prize and, in particular, as regards dealing with the exercise, by participants, of their rights of information, access, rectification, erasure and

blocking in relation to their personal data.

### Reservations and actions

FUNDACIÓN INTERMUNDIAL herein reserves the right to take all measures as appropriate to avoid any conduct it suspects may be intended as or have the effect of a fraudulent action in relation to the convening of this competition or any breach of competition rules or may harm other participants. The first and immediate consequence will be to exclude the applicant concerned who shall automatically forfeit any right to the award they may have obtained.

FUNDACIÓN INTERMUNDIAL is hereby released from any liability in the event of any error in data provided directly by the winners making it impossible to identify or notify the successful applicant.

FUNDACIÓN INTERMUNDIAL hereby excludes liability for damages of any kind that may arise as a result of temporary unavailability or discontinuance of services operation over which applications for the award are received; also regarding any disappointment users may allege regarding use of the award competition tools and, especially but not limited to, faults in accessing the various pages and dispatching of responses to applicants over the Internet.

FUNDACIÓN INTERMUNDIAL reserves the right to effect changes to ensure the award procedure is properly carried out, whenever just causes or grounds of force majeure prevent the award proceeding in the manner set out in these terms and conditions.

FUNDACIÓN INTERMUNDIAL reserves the right to cancel the award without prior notification if it has to be cancelled on grounds of force majeure deemed beyond the control of FUNDACIÓN INTERMUNDIAL or due to improper use of the award.

### Acceptance of terms and conditions

Applicants participating in the award are deemed to have accepted these terms and conditions and therefore any declaration of non-acceptance of all or part of these terms and conditions shall entail exclusion of the applicant; consequently, FUNDACIÓN INTERMUNDIAL shall be released from fulfilling any obligation with regard to that applicant.
