## 1. How to become an exhibitor at GMC 2024?

## **GLOBAL MOBILITY CALL will be held at IFEMA** MADRID, from 19 to 21 November 2024.

**EXPO -** Hall 3. The opening hours will be from 09:30 to 19:00 hours. During these hours the stands must remain open to the visiting public and be duly attended by competent staff. Exhibitors will be allowed access to the venue at 09:00. Exhibitors may remain until 30 minutes after closing time.

## 1.9

**Exhibitor's resignation:** The Exhibitor's resignation from participation is grounds for forfeiture of the amount paid in advance. ## 2.1.2 SPECIFIC ASSEMBLY RULES FOR FREE-DESIGN STANDS

Stand designs with regard to the location of stand constructions, decoration and advertising elements must respect the overall perspective of GLOBAL MOBILITY CALL and the visibility of neighbouring stands.

### HEIGHT

The maximum authorised height of stands on their perimeter line is 4 metres. A single element on the perimeter may be raised up to a height of 6 metres, except in the medians with neighbouring stands. In no case may the height exceed 6 metres.

### **BLIND ENCLOSURES**

Perimeter enclosures to corridors may not exceed 50% of each corridor. Blind enclosures of greater length must be set back a minimum of 3 m inwards and may not exceed 80% of the length of the façade.

### SIGNAGE

Signs, banners and spotlights may not protrude more than 50 cm from the allocated space, and from a minimum height of 2.5 metres, nor exceed the maximum height of 4 m. on the perimeter. The spotlights must be directed towards the inside of the stand. If in doubt, please consult IFEMA MADRID's Trade Fair Services Department.

### PACKAGING

### **APPROVAL OF THE PROJECT**

The company opting for the construction of its free-design stand must submit the assembly project to the <u>Expo Zone</u> (one month before the start of assembly), it will also be necessary to upload the service plan for its correct installation.

The interpretation and application of the regulations for each particular case will be the responsibility of IFEMA MADRID, which reserves the right to make exceptions if it considers it necessary, based on respect for the general perspective of the GLOBAL MOBILITY CALL and the visibility of neighbouring stands. The rest of the Assembly Rules will be those contained in the IFEMA MADRID General Rules of Participation.





## 6. Other participation Rules at GMC

## SAFETY REGULATIONS FOR ACCESS TO PAVILIONS DURING **ASSEMBLY AND DISMANTLING.**

For safety purposes, and as a general and permanent preventive measure due to the simultaneous occurrence of activities, it is mandatory to wear a protective helmet, a high-visibility waistcoat, and safety footwear during the assembly and dismantling phases of trade fairs and events in all exhibition areas. This measure, which is already in effect, applies to anyone entering, passing through, engaging in activities, or simply being present in pavilions or outdoor exhibition areas during assembly and dismantling tasks.

All IFEMA MADRID operational staff with continuous presence in the halls, as well as those who access them on an ad hoc basis, must adhere to this requirement of wearing personal protective equipment if the hall is being assembled or dismantled. This regulation also applies to assemblers, exhibitors, organizers, transporters, etc., who, if they lack the necessary technical equipment, can purchase it from Exhibitor Services located in the Avenida between pavilions 6 and 8 of IFEMA MADRID.

## 3. PACKAGING

The aisles, as escape routes, must remain accessible at all times, including during assembly and dismantling periods. All material must remain within the limits of the assembly areas or stands, leaving aisles and other common areas completely clear. The cleaning services will remove any object deposited in these areas, without the right to claim damages.

During the GLOBAL MOBILITY CALL, no samples, packaging or objects in general may be placed in the aisles and other common areas, nor may they be placed in the empty spaces created in the back areas of any enclosures that may be set up. There is a collection, storage and delivery service for goods and packaging, provided by IFEMA MADRID's partner company for this service, in accordance with current rates.

### 4. SPECIFIC REGULATIONS FOR ELECTRICAL INSTALLATIONS.

The IFEMA MADRID General Rules of Participation specify: Article 36. and following - All installations shall be carried out in accordance with the requirements of the Low Voltage Electrotechnical Regulations (Royal Decree 842/2002, of 2 August), Complementary Technical Instructions and any other internal provisions established by the Directorate General for Industry, Energy and Mines of the Community of Madrid. It is compulsory to submit all electrical installations carried out at the fairground to the approval of IFEMA MADRID's Technical Management. For this purpose, the Electrical Inspection Sheet must be submitted to IFEMA MADRID's Electrical Inspection Service, duly completed and stamped by an authorised installation company, which can be obtained at the inspection company's offices at the fairground.

## 5. AREAS.

In line with IFEMA MADRID's commitment to the 2030 SDGs (United Nations Sustainable Development Goals), as indicated in the Guide for sustainable participation in fairs and events and in order to optimise the process of installation and removal of recyclable trade fair carpeting for subsequent reuse and consequent elimination of protective plastic at source, the times of entry and exit of goods must be adapted to these processes.

IFEMA MADRID staff are not authorized to receive any goods destined for your stand. In order to send goods to the venue, exhibitors must indicate the delivery address as follows:

In compliance with current legislation on urban waste, all Exhibitors, as well as the companies contracted and/or subcontracted to carry out the assembly and/or dismantling of stands, are obliged to assemble, dismantle, and remove the assembly, decoration, and exhibition materials used, within the established periods of time.

Once the deadlines established for the removal of merchandise and decoration materials, as specifically established for the dismantling of stands, have elapsed, all materials that still remain in the exhibition areas of the pavilion will be considered waste materials and will be removed by IFEMA MADRID. The Exhibitor forfeits all rights to claim for losses or damages in the same, with the expenses related to their removal being borne by the Exhibitor, which will be invoiced by IFEMA MADRID in accordance with the rates established in the Price List ( $\in 100/m^2$ ), for the total square meters allocated.

In the event that the stand is not dismantled within the established deadline, the Exhibitor will pay IFEMA MADRID the cost of carrying out this service according to the budget provided by IFEMA MADRID based on the work to be done.

IFEMA MADRID will use all human and technical means at its disposal to detect possible material abandonments and will apply the aforementioned article, both in assembly and dismantling.
