1. How to become an exhibitor at MOTORTEC 2025?

Motortec

1.1. DATES AND TIMES OF PARTICIPATION

MOTORTEC will take place at IFEMA MADRID from **7-10 April 2027**, from 10:00 to 19:00h from Wednesday 7th to Friday 9th, and on the last day from 10:00 to 16:00h.

During these hours, the stands must remain open to the visiting public and be duly manned by competent staff.

Exhibitors may enter the exhibition center at **08:30h**. Exhibitors may remain until 30 minutes after closing time.

1.2. HOW TO BECOME AN EXHIBITOR

Space is contracted by filling in the **on-line Participation** Application form available on the fair website <https://www.ifema.es/motortec/expositores>

Receipt of this form at IFEMA MADRID is the first step required to exhibit at the fair.

The application must be accompanied by payment of the corresponding reservation fee.

All companies and public or private organizations whose activities are considered to be included in the sectors covered by the fair may apply to take part in the event.

The presentation of the Participation Application form implies full acceptance of IFEMA MADRID's Participation Regulations, as well as those specific to MOTORTEC and the generic provisions established by the Fair Organizers.

Exhibitors who have not paid in full for the space contracted and the costs of the services **requested will not be authorized to occupy the space and, where applicable, the modular stand** will not be handed over.

1.3. ALLOCATION OF SPACE

Former exhibitors

Preferential allocation to exhibitors from the last edition (2025).

Those who repeat participation from one edition to another may choose to keep their location or improve it as long as they maintain the same surface area or it does not vary downwards by more than 15%.

Deadline: Until 20 July 2026, only applications for space from former exhibitors of the 2025 edition will be awarded.

New exhibitors

From **21 July** onwards, the remaining applications will be allocated in order of largest to smallest surface area.

- The Management of the fair will select the location with each exhibitor and will allocate it once it has been confirmed.
- The Show Organizers reserve the right to change stand locations for justified reasons.



Exhibitors can hire only floor space to build a free design stand or hire an all-inclusive stand.

Participation as an exhibitor at the MOTORTEC fair requires the contracting of the CONECTA exhibitor PLAN at the price of 545€ +VAT (1). See details in point 9.

2.1. CONTRACTING ONLY FLOOR

The minimum area to be contracted for this modality is **32 sqm.**

Rates for space without stand:

It is also a prerequisite for starting the assembly of the free-design stand to have paid the assembly fees:

- **Rate type B:**
Basic modular stands in aluminium or similar 5,62 €/sqm
- **Rate type C:**
Modular stands with carpentry design and other materials..... 8,94€/sqm

2.2. CONTRACTING FLOOR +STAND

Minimum contract surface area: 16sqm

To these rates must be added the CONECTA exhibitor PLAN at a price of 545€ +VAT (1).

Basic and premium stands include:

- Minimum electricity consumption (0.13 kW/sqm).
- Daily cleaning of the stand (type A once a day).
- Liability Insurance (coverage up to 60.000€).
- "Multiferia" Insurance (coverage up to €50.000€).
- Assembly fees.

2.3. DISCOUNTS

- **5% discount for early payment** on the floor rate, provided that 100% payment is made before 28 november.
- **5% discount for exhibitors** of the last edition, redeemable for consumption vouchers.

2.4. SURCHARGES

- **25% increase** for those services requested 7 days before the start of the assembly (7th April).
- **25% increase** when the hiring of assembly rights takes place during the week prior to (7 days before) the start of the assembly, during the assembly, celebration and dismantling.

3. Co-Exhibitors

Motortec

A co-exhibitor is any company participating in the Show in the same space as the company owning the stand.

In order to have access to all the elements included in the Conecta Exhibitor Plan, each exhibitor must complete the Participation Application Form, which includes the Conecta Exhibitor Plan concept, the fee for which is €545 +VAT (1).

4. Assembly rules for free-standing stands (contracting only floor)

Motortec

MINIMUM SURFACE AREA FROM 32 SQM

The designs of the stands in terms of the location of their constructions as well as their decoration and advertising elements must respect the general perspective of the Exhibition and the visibility of neighbouring stands.

HEIGHT

The maximum authorized height of stands on their perimeter line is 4 m. A single element on the perimeter may be raised up to a height of 6 meters, except in the medians with neighbouring stands. In no case may the height of 6 meters be exceeded.

BLIND ENCLOSURES

Perimeter enclosures to aisles may not exceed 50% of each aisle. If blind enclosures of greater length are to be erected, they must be set back a minimum of 3 m inwards and may not exceed 80% of the length of the facade.

Any element that prevents or limits the view of the stand, whether it is formed by constructive elements or by the arrangement of decorative elements, is considered to be an enclosure.

SIGNAGE

Signs, flags and spotlights may not protrude more than 50 cm. from the allocated space, and from a minimum height of 2.5 meters, nor exceed the maximum height of 4 m. on the perimeter. The spotlights must be directed towards the inside of the stand. If in doubt, please consult IFEMA MADRID's Trade Fair Services Department.

PACKAGING

Packaging will not be allowed to be stored inside the hall. For this service, please request information from the Exhibition secretary's office.

PROJECT APPROVAL

Companies opting for the free-design construction of their stand must send their assembly project to IFEMA MADRID's Trade Fair Services Department for approval at least one month before the start of assembly: floor plans and dimensioned front and side elevations.

The interpretation and application of the regulations for each particular case is the responsibility of IFEMA MADRID, which reserves the right to make exceptions if it deems it necessary, based on respect for the general perspective of the event and the visibility of neighbouring stands.

GUIDING DRAWING: It is not allowed to pierce or nail elements to the stand. It is possible to use adhesive tape or graphics, which are easily removable and do not damage the panels.

In the case of companies from the European Union, the exhibitor will be responsible for the VAT which, where applicable, is due in their country of establishment.

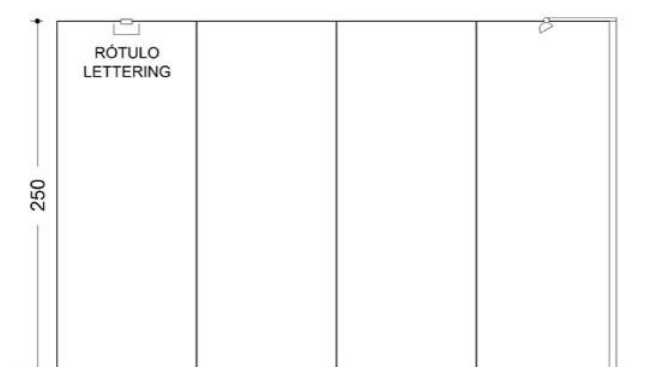

6. Turnkey stand assembly standards

Motortec

MINIMUM SURFACE AREA FROM 16 SQM

Send a **plan of the modular stand** with the distribution of the different services and complements to the Exhibition Services Department (atencionalcliente@ifema.es).

In the Exhibitors' Area/Contracting Services, indicate the color of the wall, carpeting and signage according to the modular stand contracted.

If the wall color is not indicated, the default color will be WHITE.

REMARKS:

- 1** All services or modifications that may be introduced based on these characteristics shall be at the exhibitor's expense. The elimination or substitution, by the exhibitor, of any formative element of the modular stand does not imply a reduction in the cost.
- 2** The distribution of all the elements that make up the stand, the extras requested, as well as the structural elements necessary for the support of the stand, shall be adapted to the needs of the exhibitor, provided that it is technically feasible and that the plan with the relevant indications is received fifteen days before the first day of the start of assembly.
- 3** Once the stand has been assembled, any changes to the location of all the elements that have not been communicated on the established date will be invoiced.
- 4** All the material used, both structural and electrical, is rented and any deterioration will be invoiced according to the current rates.
- 5** The elimination, by the exhibitor, of any training element of the prefabricated stand does not imply a reduction in cost.



- Once the space has been allocated, you will have access to the IFEMA MADRID Services Catalogue, which includes the services that can complement your participation in the fair. These can be contracted through ifema.es/motortec in the Exhibitor Area.
- **Until 12 March 2027:** if you contract services through the Exhibitors' Area, a **5% discount** will be applied. These rates are subject to periodical modification depending on the evolution of costs. Updated prices are available at the time of contracting on the institutional website in the Exhibitor Area space.
- This discount will also be applicable to the services included for your location in the plan of your stand sent to the Technical Secretariat up to 30 days before the start of assembly.
- Mandatory minimum services, outdoor advertising, meeting rooms, graphic decoration of stands and Specific Services of the fairs such as exhibitor passes, etc.) are NOT included.

Maximum sound level

According to IFEMA's general regulations, noisy demonstrations are prohibited, and the level of 60 decibels measured at the edge of the stand must not be exceeded.

Any activity such as musical performances by bands, DJs, or similar must have express authorization from the management of the event and, in any case, must always take place from 6:00 p.m. onwards.

If the indicated sound level is exceeded, IFEMA MADRID staff will require the Exhibitor to lower the volume to the indicated limits. In case of refusal or repeated non-compliance with the rule, IFEMA MADRID staff may cut off the electrical supply to the stand and, if necessary, close and shut it down, without the Exhibitor having the right to a refund of paid amounts or any compensation.

12.1. SAFETY REGULATIONS FOR ACCESS TO HALLS DURING ASSEMBLY AND DISMANTLING

For safety reasons, and as a general and permanent preventive measure due to the concurrence of activities, it has been made compulsory to wear a protective helmet, high-visibility waistcoat and safety footwear during the assembly and dismantling phases of fairs and events in all exhibition areas.

This measure affects any person accessing, passing through, carrying out activities or simply being present in pavilions or outdoor exhibition areas during assembly and dismantling tasks. This **regulation extends to assemblers, exhibitors, organizers, transporters, etc.**, who, if they do not have the necessary technical equipment, can purchase it in **Halls 6 - 8 from Exhibitor Services.**

12.2. ACCESS TO THE EXHIBITION

- In order to guarantee the professional nature of the Fair, access controls will be carried out to validate the correct reading of the passes during access to the Fair.
- Each exhibitor may request additional Exhibitor Passes **at a cost of €4.57/each. + VAT***.
- The online professional invitations will be available in the Exhibitors' Area, so that each exhibitor can send them to their clients, who must register online in order to obtain the **direct access pass to the Fair.**
- Each exhibitor will receive, depending on the allocated space, the following number of exhibitor passes and online invitations for their clients.

12.3. INSTALLATION OF RECYCLABLE CARPETING IN COMMON AREAS

In line with IFEMA MADRID's commitment to the 2030 SDGs (United Nations Sustainable Development Goals), as indicated in the Guide for sustainable participation in fairs and events. In order to optimize the process of installation and removal of recyclable trade fair carpeting for its subsequent reuse and consequent elimination of protective plastic at source, the times of entry and exit of goods must be adapted to these processes and will be as set out in point 15 Exhibitor Calendar.

12.4. ASSEMBLY FEES

In order to be more efficient and to be able to offer you a better service, avoiding incidences in the assemblies, **from 31st March, 2027/2025**, we will apply the surcharge for last minute contracting to the contracting of the assembly rights, as it happens with the rest of our services.

This surcharge **increases the price by 25% when the booking is made during the week prior (7 days before) to the start of the assembly**, during the assembly, celebration and dismantling.

We would like to remind you that the assembly fees apply to free design assemblies and that they can be contracted with a 5% discount if the contract is made up to 30 days before the start of the fair assembly.

• We offer our exhibitors a service that includes the removal and management of the waste they/their assemblers generate. (check our fees in Exhibitors' Area).

Carpet recycling:

IFEMA MADRID recycles 100% of the carpeting used in aisles and communal areas. To do so it has been essential to change our assembly and disassembly process, that affects the entry and removal of goods (check the corresponding item) . Furthermore, means that it has to be laid in strips instead of covering the entire surface area as was previously the case. This means we can guarantee its conversion into a new raw material for the subsequent manufacture of other products.

SUSTAINABLE MOBILITY:

IFEMA MADRID offers access to public transport close to its facilities (metro and bus), parking for electric cars with 100% renewable electricity charge points, as well as a parking area for bicycles and scooters

15. Removal of waste generated

The IFEMA MADRID General Participation Regulations specify:

Article 35.- "Removal of waste and assembly and exhibition materials. In application of current legislation on urban waste, all Exhibitors, as well as the companies contracted and/or subcontracted to assemble and/or dismantle stands, are obliged to assemble, dismantle and remove the assembly, decoration and exhibition materials used, within the time periods established for this purpose.

Once the deadlines established for the removal of goods and decoration material and those specifically established for the dismantling of stands have elapsed, all materials still remaining in the exhibition areas of the hall will be considered waste materials and will be removed by IFEMA MADRID, the Exhibitor forfeiting any right to claim for loss or damage to the same, the Exhibitor being responsible for the costs related to their removal, which will be invoiced by IFEMA MADRID in accordance with the rates established in the Price List (100€/m2), for the total square meters allocated.

If the stand is not dismantled within the established period, the Exhibitor shall pay IFEMA MADRID the cost of carrying out this service in accordance with the estimate provided by IFEMA MADRID based on the work to be carried out.

IFEMA MADRID will use all the human and technical resources at its disposal to detect possible material abandonment and will apply the aforementioned article, both during assembly and dismantling.

IFEMA MADRID can hire the necessary containers at the following rates:
